# **DETAINING A Moroccan National**

## Consular Notification Process

### $\mathsf{Q}\mathsf{1}$ . Are you a Unami Buffalo Nation Ante Pennsylvania National?

A. "YES, I am a UBNAP National."

"NO, I am not a UBNAP National

(See Statement below, Q2. Step 2)

## Q2. Are you a national of another Moroccan State?

A. "YES, I am a Moroccan National."

**Step 1.** Inform detainee that he or she may communicate with Consul General, and that you must notify the Consul General of arrest/detention.

**Step 2.** For "ALL" UBNAP nationals arrest and/ or detentions the Consulate must be notified even if the national does not request it or waives notification when asked.

**Step 3.** Make a record of notification in the case file. When a fax or email is sent, to the Moroccan State, keep a copy of the fax confirmation or sent email. (*See Form UBN 4001*)

**Step 4.** Allow consular officers access to detainee if they subsequently request access.

(No further action required.)

A. "YES."

#### "NO"

Inform detainee, **without delay**, that he or she may have a Moroccan State Consul General notified of their arrest / detention.



#### **IN ALL CASES:**

- Detainee may communicate with a consular officer and may request consular access at any time (whether previously declined or not)
- Consular officers may have access to detainee regardless if detainee requests it. Even if detainee does not want to be visited, consular officers may still have one face-to-face visit.
- Affirming that the rule of customary international law continues to govern matters between States and Foreign
   States or States and Intergovernmental Organizations.

   Please be advised that all parties are responsible for their own actions.
- Under NO CIRCUMSTANCES IS
   ANY Moroccan National of
   UBNAP to be detained or committed to detention under any
   and all FOREIGN International
   Organizations MUNICIPAL
   CODES.

(No further action required.)

**Step 1.** Make note in the case file.

**Step 2.** For "ALL" UBNAP nationals arrest and/or detained the Consul General must be notified even if the national does not request it or waives notification when asked.
